Mandatory Rehearsal Dress Code: Casual and modest

Registration: \$25 registration fee must be received by October 5th; \$30 for all registration received October 6th and on. **Registration closes October 30th or when 450 person capacity is reached.**

The Gentleman's Dress Code:

- Dress shirt (no casual prints), slacks (no blue jeans), tie, dress shoes (no tennis shoes), no hats
- Tuxedos are welcome, though not required.
- We reserve the right to turn away any gentleman not dressed according to the dress code, without refund.

The Lady's Dress Code:

- Formal dress or skirt, mid-calf or longer. Knee length, including hi-low style, is too short.
- No strapless tops
- Midriff must be covered; no cleavage line showing
- Dress shoes up to the task of zealous dancing; ballet slippers are recommended over high heels. No tennis shoes allowed.
- We reserve the right to turn away any lady not dressed according to the dress code, without refund.

The Gentleman's Code of Conduct:

- The gentleman will ask the lady to dance, not the other way around. Escort the lady off of the dance floor at the end of the dance.
- A gentleman is encouraged to dance with a lady no more than twice after the Grand March unless the two are engaged or married.
